#### **Conflict Resolution Procedure and Vote**

Complaint #1: "BFA's Administration being unable to understand, follow, enforce and ensure compliance with the Discipline Policy "consistently, fairly and uniformly" as required by law." Board Decision: The Board affirms the actions by the Ben Franklin Academy (BFA) Administration and has determined that it is able to understand, follow, enforce, and ensure compliance with the Discipline Policy consistently, fairly, and uniformly.

Board Vote: There are no objections to the decision by the Board, and all seven (7) Board members unanimously approve the decision.

Complaint #2: "BFA's Administration is unable to ensure Grading Policy adherence consistently."

Board Decision: The Board affirms the actions taken by the BFA Administration and has determined that it is capable of adhering to the Grading Policy consistently, and any issue therewith has been resolved, therefore, the complaint is moot.

*Board Vote:* There are no objections to the decision by the Board, and all seven (7) Board members unanimously approve the decision.

Complaint #3: "BFA's Administration and Board neglecting to investigate properly reported Bullying incidents as required in the Handbook. This includes a racial Bullying incident." Board Decision: The Board understands that investigations, classroom observations, and staff intervention were executed successfully by the Administration and that the issues were not deemed willful and/or credible, nor did the behavior meet the definition pursuant to the Parent-Student Handbook.

*Board Vote:* There are no objections to the decision by the Board, and all seven (7) Board members unanimously approve the decision.

Complaint #4a: "BFA's Administration being unable to enforce and ensure that Colorado and Federal laws are followed consistently, fairly, and uniformly pertaining to enforcement of BFAs Discipline Policy with regard to C.R.S. 22-32-109.1"

Board Decision: The Board asserts that it does not have the authority to determine if an action under C.R.S. 22-32-109.1 is considered to be either legal or illegal and therefore abstains. Board Vote: There are no objections to the decision by the Board, and all seven (7) Board



members unanimously approve the decision.

Complaint #4b: "BFA's Administration being unable to enforce and ensure that Colorado and Federal laws are followed pertaining to individualized ALPs with S.M.A.R.T. goals and S.M.A.R.T. progress updates for Reading in regard to ECEA."

*Board Decision:* The Board asserts that it does not have the authority to determine if an action under ECEA is considered to be either legal or illegal and therefore abstains.

*Board Vote:* There are no objections to the decision by the Board, and all seven (7) Board members unanimously approve the decision.

Complaint #4c: "BFA's Administration being unable to enforce and ensure that Colorado and Federal laws are followed pertaining to decision and notification of a right to a hearing in regard to FERPA"

*Board Decision:* The Board affirms that the Administration has addressed the issue herein by contacting families and officially changing affected student grades, thus the issue is deemed resolved and therefore moot.

*Board Vote:* There are no objections to the decision by the Board, and all seven (7) Board members unanimously approve the decision.

Conclusion: All seven (7) Board members unanimously approve all decisions produced by the Board concerning the parent grievance alleging misconduct by staff, Administration and the Board in pursuant to the Conflict Resolution Policy.
